
S#	Name of Rejected firm	Reason for Rejection
1	M/s 8ways Communications, Islamabad	The firm has deposited low earnest money i.e. Rs.29,000/- instead of Rs.1,500,000/- hence, the firm is rejected as per Sr.No. V of Terms and Conditions read with quoted price at e-PADS.
2	M/s Office Automation Group, Islamabad	The firm has deposited low earnest money i.e. Rs.2,000/- instead of Rs.350,000/- hence, the firm is rejected as per Sr. No. V of Terms and Conditions read with quoted price at e-PADS.
3	M/s Good Luck Traders, Islamabad.	The firm has submitted affidavit on Rs.100/- stamp paper instead of Rs.200/-Therefore, the firm is rejected as per Sr. No. X of Terms and Conditions.
4	M/s Apex Automation Group Solution, Islamabad	The firm has not attached a copy of Pay Order with Technical Proposal, therefore, the firm is rejected as per Sr. No. V of Terms and Conditions.
5	M/s Attique Traders Office, Islamabad.	The firm has deposited low earnest money i.e. Rs.1,750/- instead of Rs.450,000/- and also submitted affidavit on Rs. 100/- stamp paper instead of Rs. 200/-. Therefore, the firm is rejected as per Sr.No. X of Terms and Conditions.


