In the technical evaluation, M/s ADR ODR International met the mandatory requirements and obtained 52.5 marks and was declared technically qualified on the basis of eligibility criteria, i.e. minimum 36 marks (60% of 60 marks). Based on the technical and financial combined evaluations, M/s ADR ODR International has obtained the final score of 71.50 and is single most advantageous bidder.

As M/s ADR ODR International is the single qualified bidder, the Procurement Committee after detailed deliberations found that the rate quoted by the firm is reasonable and within the allocated budget in PC-1. The rate quoted by M/s ADR ODR International in the previous procurement for training of mediators was also found lowest and the services performed by the firm were satisfactory. Therefore, the Procurement Committee recommends the award of contract to M/s ADR ODR International being the most advantageous bidder for Procurement of Services for Accredited Training of Mediators.


